## IN THE CIRCUIT COURT FOR THE COUNTY OF CULPEPER COURTROOM DRESS AND CONDUCT CODE

In Order to maintain order and to uphold the security, dignity, and decorum of the Court, the following dress code is applicable to all persons entering the courtroom of the Culpeper County Circuit Court:

- NO CLOTHING THAT EXPOSES BARE MIDRIFFS
- NO EXPOSED UNDERWEAR
- NO TUBE TOPS, HALTER TOPS, OR SPAGHETTI STRAPS
- NO CUT OFF JEANS OR CUT OFF SLACKS
- NO MINI SKIRTS OR SHORT SHORTS
- NO HEAD GEAR OF ANY KIND EXCEPT FOR ITEMS WORN FOR RELIGIOUS OR MEDICAL REASONS
- NO CLOTHING WITH OBSCENE OR VULGAR WORDING OR PICTURES
- SHIRT TAILS MUST BE TUCKED INSIDE OF PANTS, UNLESS THE SHIRT IS DESIGNED TO BE WORN OVER THE BELT LINE
- SHOES MUST BE WORN AT ALL TIMES; NO BEDROOM SLIPPERS PERMITTED

NEEDLEWORK OR ANY ITEM CONSIDERED A WEAPON WILL NOT BE PERMITTED IN THE COURTHOUSE

LAW ENFORCEMENT AND OFFICERS OF THE COURT ARE PERMITTED TO HAVE PAGERS AND/OR CELL PHONES THAT ARE SET ON VIBRATE ONLY
