## **OPTIONS - Programs for At Risk Youth**

Here at OPTIONS we have been working with youth in our community by focusing on three values: taking care of the body, giving back to the community and making better decisions in your life. The overall goal is to meet our youth where they are at now, to help them to succeed in the future.

Our Healthy Youth Initiative Program is a County program designed to provide opportunities for youth ages 11-17 years old to get involved in physical activity. Youth are transported to PATH Recreation and Fitness Center to participate in a one (1) hour work out session with a Certified Personal Trainer. The exercises consist of cardio exercises, weight lifting, core exercises, or other exercises. The program has the capacity for youth to go twice a week. The clients we have participating in this program have benefitted by working on their own personal fitness goals as well as working on social interaction with adults and with their peers.

With community service we have put a great emphasis on placing our youth at sites for them to understand the need of taking pride in giving

back to the community. Two of the local sites we have been having youth work at are Manna Ministry, assisting with serving meals and the USDA Food Distribution through the Culpeper United Methodist Church. Here at OPTIONS the kids have been working with our new community service project called Back to Nature. This project is focusing on the clients working with their hands by building birdhouses and cultivating a garden. The objective of Back to Nature is for the birdhouses that have been built by our clients to be donated to local agencies and nursing homes. With the garden we want our youth to take pride in learning how to garden and harvest a garden. The goal for this project is for the vegetables harvested from the garden to be donated to local food pantries. OPTIONS would like to graciously thank Whole Heart Farm for their donation for the lumber to make the birdhouses. We would also like to thank our local Master Gardeners and Friends of the Rappahannock for their help with this project.



We want the youth to understand that they are not defined by their negative decisions, but can learn from them. Here at OPTIONS we have a youth participate in the Decision Points program. Decision Points is a revolving five (5) session openentry evidence-based cognitive behavior intervention program designed to equip youth participants with alternative ways to examine their thinking and the related actions that lead them into trouble. It creates a practical pathway for change and challenges youth to create alternative non-risk thoughts.

#### ABOUT THE COMMUNITY INVESTMENT COLLABORATIVE

Community Investment Collaborative, more commonly known as CIC, was initially formed to address financing difficulties faced by micro-enterprises in the region. Founded in 2011 from the personal experience of Toan Nguyen, owner of C'Ville Coffee, the organization is the result of a workgroup of 48 professionals with nonprofit, business, and education backgrounds, who came together to determine a productive solution that could yield tangible resources for entrepreneurs for years to come. CIC's mission is to strengthen the community and contribute to economic development by fueling the success of under-resourced entrepreneurs.

In 2020, CIC became the host organization for the Central Virginia Small Business Development Center (CVSBDC) to offer additional benefits to its target market and other small business owners. In 2021, it gained its Community Development Financial Institution (CDFI) certification. As a CDFI, Ioan funds include partnerships with 5 local governments, funding from the U.S. Department of Agriculture and the Treasury Department's CDFI Fund, among other sources, which combined, has availed over \$2.1 million to over 175 local entrepreneurs. Earlier this year, the CDFI classification also afforded CIC an opportunity to become a recipient of a \$550,000 grant through the Virginia Small Business Resiliency Fund, an initiative which seeks to build CDFIs capacity to create programs and products that increase access to capital and technical assistance for underserved COVID-19 impacted businesses in the Commonwealth. This award and others will help extend CIC's microlending to the Culpeper small business community.

On the cusp of its 10-year anniversary, today, CIC not only offers financing but also education, mentoring, and networking opportunities, including its signature program, a 16-week entrepreneur workshop, which, to date, has nearly 500 graduates. Each component helps to cultivate a local business network that connects aspiring entrepreneurs with existing entrepreneurs, city officials with nonprofit service providers, and state agents with local businesses, bringing together the impressive experience and expertise found not just in Charlottesville, but in its entire service area of Albemarle, Fluvanna, Greene, Louisa, Nelson, Orange, Madison, Rappahannock, and Culpeper.

CIC strives to push the needle forward and evolve with the needs of the community it serves. Its enhancements are persistent and its goals are ambitious to match its desired impact.

The Brandy Station Foundation operates the Graffiti House at 19484 Brandy Road in Brandy Station which contains Civil War graffiti and a museum. The Graffiti House is a two-story frame structure built in 1858. We like to say that its walls "talk"; they contain inscriptions, drawings, messages, and signatures of both Union and Confederate soldiers, hence the name "Graffiti House." On June 18, 2022 the Brandy Station Foundation will present a free event titled "The 159th Anniversary of the Battle of Brandy Station: Then and Now" beginning at 1:00 PM at the Graffiti House, 19484 Brandy Road in Brandy Station. Planned activities include tours of the Graffiti House, the battlefield, music, lectures and a multispectral demonstration that allows you to see beneath the visible graffiti. BSF Vice President Howard Lambert will present a talk on Juneteenth, the June 19th holiday commemorating the end of slavery in the United States. The date celebrates the enforcement of Abraham Lincoln's Emancipation Proclamation in Texas on June 19, 1865.

#### CULPEPER BATTLEFIELDS STATE PARK

The Brandy Station Foundation is a member of The Friends of Culpeper Battlefields—a coalition supporting battlefield-focused preservation, stewardship, and heritage tourism across the historic Culpeper region. On January 21, 2022, Virginia Governor Glenn Youngkin submitted a budget amendment request to set aside \$4.93 million in FY 2023 for land acquisition to create a Culpeper battlefields state park. # Mental Health - Nurture the Garden of **vour Mind!**

As we relish the spring season with blossoming trees and flowers; nature reminds us that things are coming to life. Nurturing the garden of our mind is even more important than that of our flowerbed. Good mental health is a key aspect of overall wellbeing!

Mental Health America 2022 data showed that in comparison to other states, Virginia ranked ninth for its prevalence of adult mental illness, and eighth for adults with serious thoughts of suicide. Mental illnesses are common in the United States. Nearly one in five U.S. adults lives with a mental illness.

The Rappahannock Rapidan Health District supports mental health awareness during the month of May.



The Centers for Disease Control and Prevention, CDC acknowledges that the COVID-19 pandemic has had a major effect on our lives. Many of us are facing challenges that can be stressful, overwhelming, and cause strong emotions in adults and children. Public health actions, such as social distancing, are necessary to reduce the spread of COVID-19, but they can make us feel isolated and lonely and can increase stress and anxiety. Learning to cope with stress in a healthy way

will make you, the people you care about, and those around you become more resilient.

Mental health includes our emotional, psychological, and social well-being. It affects how we think, feel, and act. It also helps determine how we handle stress, relate to others, and make healthy choices. Mental health is important at every stage of life, from childhood and adolescence through adulthood.

People can experience different types of mental illnesses or disorders, and they can often occur at the same time. Mental illnesses can occur over a short period or be episodic. This means that mental illness comes and goes with discrete beginnings and ends. Mental illness can also be ongoing or long-lasting. There are more than 200 types of mental illness. The disAbility Resource Center, a Center for Independent Living (CIL) for people with disabilities, is excited to be developing and offering new trainings this spring. While the Town and County of Culpeper and the counties of Orange, Madison, and the lower Rappahannock are not within the service area of a Center currently, town and county residents are welcome to participate in dRC trainings.

On Tuesday and Thursday afternoons until June 7<sup>th</sup>, the dRC is offering Bingocize classes. A new class will be scheduled after this one ends. While Bingocize emphasizes fall prevention and was developed for seniors, it is a fun way to enjoy simple yet productive exercises for anyone. Contact Tennie at trgatz@cildrc.org or 540-373-2559 for information on future classes. Other trainings and activities are listed on the dRC website, www.cildrc.org.

The disAbility Resource Center has a grant to do COVID vaccination outreach to individuals with disabilities. The dRC held two small vaccination clinics at their office in March to help those who are not comfortable in larger, community settings for their shots. If you or a loved one still have not received your vaccine, we can help you find out where to get one, help you find transportation to the vaccination

site, provide you with current vaccination information and more. We are also documenting barriers to the vaccination and ask people to contact us so we can record what those barriers are. Please call the dRC at 540-373-2559 to report any reason you have not received the shot or to request help getting the vaccination. CILs are community-based organizations meaning they are formed by people in the community in which they serve. They help Individuals by providing independent living skills training, peer mentoring, information and referral, advocacy, and transitions services (from nursing home to one's own home and transition from high school to adult life). CILs also provide local services that they feel their community might need, for example, specific trainings, durable medical equipment loans, and benefits planning, to name a few. If anyone in the greater Culpeper area is interested in services that help people with disabilities become more independent and in developing a CIL in that part of the Commonwealth, contact Debe Fults, dRC Executive Director, at dfults@ cildrc.org or 540-373-2559.

In this issue of the Culpeper Quarterly, we would like to highlight some information about our Records Room. If you have never visited to do a search, I highly recommend a trip. I have always found history interesting, and we have a plethora of history of our very own County. We have some truly fascinating records. This is Part I of a multi-part series to highlight the various types of records we maintain.

The Circuit Court Clerk's Office record room is open from 8:00 am to 4:00 pm.

On-site, we have Birth Record indexes from 1864 – 1896 & 1912 – 1917.

- Actual Birth Records 1912 1917.
- Death Records indexes from 1865 1895 & 1912 1917
- Actual Death Records 1912 1917
- Wills 1749 to current (we are missing the Will books G, L, M)
- Marriage 1781 to current (indexes start in 1781; however, actual marriage records start in 1839)
- Deeds and land records 1749 to current

The records above are indexed by last name and year.

- To search records from 1996 to current you will need to use a computer in the records room searching last name, first name. The list will appear on the right and you can select the correct item and it will open the document on the right. If you would like to print (\$.50 a page), please select the print option over the document and it will print to a printer located behind the front counter.
- To search 7/1/1946 to 12/31/1996 (land records only) select special index option and proceed based on last name and year again.
- To search land records prior to July 1, 1946, you will look at an index book based on the last name of either the Grantee or Grantor index and the section of years you believe the transaction to have taken place. The index books will then refer you to the actual book and page where the document will be located.
- When searching for a plat, you will need to review your deed and see if it references a plat. If the deed has a plat reference, then you will search for that reference. The plats can be found in old deed books, in large green plat cabinets, and on the plat computer all of which are located in our Records Room. Not all plats are recorded, and we will only have a record of a plat if it was brought into our office to be recorded.

The Library of Virginia has stored all our old chancery suits from 1829 thru 1913. Library of Virginia Website: https://www.lva.virginia.gov/chancery

- Search the Index.
- Go to County you would like to search.
- You have 3 options "equals" "starts with" "includes" to search.
- If you use Surname easier to use starts with rather than equals, then search (caution things are not always spelled the same as they are today).
- The Local Case # is the number that can be found in our old chancery index i.e. 92- If you use the number you may have multiple entries as several cases were once together, so scroll down until you see the names you are looking for.
- Once you find your case Click on View Details this will allow you to view the images online.

The Circuit Court Clerk's Office does not have the staffing to perform individual searches, but can assist the public with questions on "how to" search.

# <u>Commissioner's</u> <u>Office considers high</u> <u>mileage when valuing</u> vehicles



#### Most Popular Question:

Does my vehicle have to have over 100,000 miles in order to make application for high mileage adjustment?

#### Answer: NO.

By law, if mileage is taken into consideration as an adjustment to the January 1<sup>st</sup> assessed value, the adjustment must be determined using the mileage table included with the January issue of the J. D. Power Official Used Car Guides (formerly NADA). The effect of mileage for qualifying vehicles will vary according to the class and age of the vehicle. If you believe your vehicle may qualify for a value adjustment due to high mileage, please complete a high mileage application, attach third party documentation and submit to the Commissioner of the Revenue. Applications may be obtained online or by contacting the Commissioner's office. Documentation must be legible and must indicate mileage on or before January 1<sup>st</sup> of the tax assessment year seeking such adjustment. Documentation may be in the form of a state inspection receipt (displaying year, make, model and VIN), oil change or service center repair receipt, or simply have the garage read your odometer and document it. In order to ensure the highest value reduction, submit documentation indicating the mileage as close to January 1<sup>st</sup> as possible. As always, if you have any questions, please stop by, call or email me.

Please note that the documentation must be submitted annually until the mileage reaches 245,001 High mileage adjustments are not available on motorcycles, motor homes, large trucks or trailers



# Employee Spotlight James Herring

My name is James Herring. I was born in Fairfax, and raised in Albemarle County. I have worked in the Criminal Justice field since 2013. While attending Old Dominion University, where I obtained a degree in Criminal Justice, I was hired as a police officer in Albemarle County. I was a police officer for almost five years, before being accepted into law school.

I attended Liberty University School of Law from 2015 to 2018. I took and passed the Virginia bar exam in 2018. Once I became licensed, I was hired as an Assistant Commonwealth Attorney in Albemarle County. I served in that capacity for one year, before being hired in Culpeper County.

I have been with the Culpeper County Commonwealth Attorney's Office since 2020. I married my beautiful wife that same year and we are looking forward to starting a family of our own. I look forward to continuing to serve the citizens of Culpeper County.



#### Notable Case this Quarter

This February, our office had a multi-day sexual assault jury trial. Two Assistant Commonwealth's Attorney's tried the case in the Culpeper County Circuit Court. The Defendant was found guilty of two counts of sexual assault by the jury. Sentencing is set for the spring of 2022.

#### Drug Court Update

After 4 years of planning and preparation, I am so very pleased to announce that the Culpeper County Drug Court held its first session on March 1, 2022. The court will continue to meet on a weekly basis and provide the County's first intensive out-patient treatment program for both men and women through the Criminal Justice System.

On December 17<sup>th</sup>, 2021 the program was awarded a grant for \$549,094 from the U.S. Department of Justice. This grant will cover 4 years of operating costs for the court.

Drug Court is an intensive program that requires a minimum of 14 months of participation. Within those 14 months participants will go through elevated supervision from both District 26 Probation and the Rappahannock-Rapidan Community Services Board. This supervision includes daily drug testing and 9 hours of out-patient substance abuse treatment a week.

To be a participant in this program there are certain specific criteria that a defendant and their case must meet, some of these include:

- The defendant's pending case must be a non-violent drug offense (to include deferred dispositions and felony probation violations);
- The defendant must be over 18 and a resident of Culpeper County;
- Can not be a convicted Sex Offender; and
- Can not have a drug distribution conviction within the last 10 years where the facts prove the crime was committed for monetary purposes and not based on a personal addiction.

While there are "Best Practices" policies and procedures that are handed down by the Virginia Supreme Court and the National Drug Court Organization, which we use in our court, each drug court is different. In Culpeper, Criminal Justice agencies and beyond have come together to form a team that run the program. The team working with the program is made up primarily of Andrew Lawson (Acting Coordinator), Paul Walther of the Culpeper Commonwealth Attorney's Office, Carson Beard of the Culpeper Circuit Court, Donna Frazier District 26 Probation, The Rappahannock-Rapidan Community Services Board, members of the Culpeper Police Department and the Culpeper County Sherriff's Office, and defense representatives Monica Chernin and Kevin Smith. Drug Court is presided over by The Honorable Judge Susan Whitlock. The team takes a unified approach to help participants through the program and it would not be able to work without each member doing their part.

Drug Court is still a work in progress but the steps taken so far are promising. Our four-year goal is to have the court running at full capacity of 30 - 40 participants at a time.

"It has been a long journey and it's nice to be able to now say that, here in Culpeper, we have another way to address the drug epidemic, one that includes utilizing long-term drug treatment for this health problem. Drug court allows us to keep families together, address core issues, and not spend thousands of dollars on incarceration." Paul Walther
