

Litter Pickup 13 years of Operation

In July 2006, CJS began the Litter Control Program. Over the past 13 years, probationers have cleaned 13,010 miles of Culpeper roadways.

The Board of Supervisors decision to create the Litter Control Program continues to produce benefits for every citizen of Culpeper.

Since 2006: 620,821 pounds of trash

FY19 data:

18.10 tons of trash picked up (2,129 bags)

789 miles of roads cleaned

2,363 hours of community service

50 tires removed

In-House Services

CJS staff conduct risk and need assessments, case planning, motivational interviewing, substance abuse testing and screening, Litter Control and facilitate Moral Reconciliation Therapy (MRT). CJS also refers and monitors probationer's placement in services as listed in **Placement in Services**.

CJS staff are focused on recidivism reduction and are tasked with assisting probationers to lower their criminogenic risk factors by assisting them with increased internal motivation, prosocial thought processes, prosocial activities, prosocial peers, prosocial family relationships, and skill building.

CJS staff also assist probationers with job searches and financial management.

Culpeper County Criminal Justice Services (CJS) probation provides local probation services to misdemeanor and non-violent felony placements.

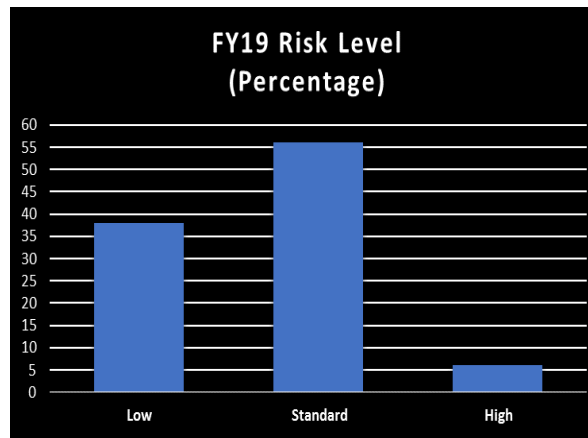
The mission of Culpeper County Criminal Justice Services is to promote public safety and assist in the fair administration of justice through the utilization of evidence-based practices.

FY 2019 Probation Placements

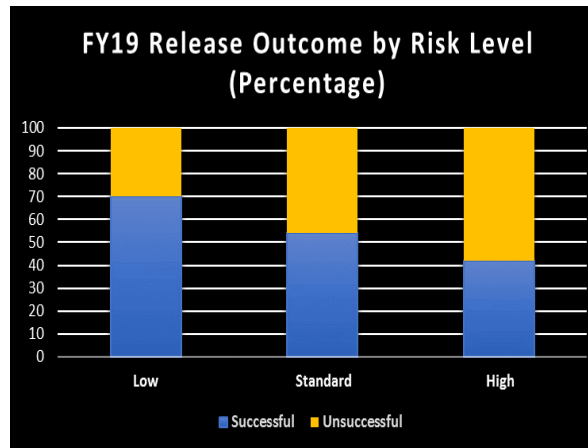
Individuals Placed on Probation	293

Risk Level Data



The above graph indicates the risk level of probationers that were placed with CJS and their cases were closed in FY19 as either successful or unsuccessful.



The above graph indicates how probationers were released in FY19 according to their risk level. Risk level data has remained consistent throughout the years and is a strong predictive factor of probation success or failure.
