



LAUREL VALLEY CONVENIENCE CENTER RULES

Convenience center boxes are for COUNTY residents, property owners, or authorized permit holders to dispose of household waste normally produced from household activities & bagged in plastic or other bags. Large items, bulky waste & vehicles fully loaded with household trash may be directed to the Transfer Station Scales at the discretion of the Center attendant.

RESIDENTIAL HOUSEHOLD TRASH UNDER 500 POUNDS ONLY!

(UNLOAD IN ONE SECTION ONLY)

IF OVER 500 LBS, DUMP IN BUILDING ONLY

ABSOLUTELY NO DUMPING ON THE GROUND

PROOF OF RESIDENCY IS REQUIRED

(FARM USE VEHICLES will be required to provide proof of County residency)

SCAVENGING IS NOT PERMITTED

NO TRESPASSING AFTER BUSINESS HOURS!

UNACCEPTABLE MATERIALS INCLUDE (BUT ARE NOT LIMITED TO):

LIQUID WASTE
DEAD ANIMALS
DRUMS OR STORAGE TANKS
HAZARDOUS MATERIALS
REGULATED MEDICAL WASTE
COMMERCIAL AND INDUSTRIAL WASTE
BULKY WASTE
TOXIC WASTE
FRIABLE ASBESTOS

COMPRESSED GAS CYLINDERS
FLAMMABLE/EXPLOSIVE OR CORROSIVE
MATERIALS
LOGS OVER 6" IN DIAMETER
JUNK VEHICLES
BOARDS OVER 8' LONG
CONCRETE/ASPHALT LARGER THAN-
BASKETBALL
PIPES OVER 6" IN DIAMETER

*DRUMS OR STORAGE TANKS should be cut in half

*APPLIANCES and other salvageable metals should be placed in recycling area

The Laurel Valley Contract Operator and or the County Administrator have the authority to prosecute any resident who deliberately violates the Contract Operator or Convenience Site Attendants instructions as to the safety or proper placement of refuse materials. This directive is given to ensure the orderly operation of the Transfer Station and the Convenience Center site.

ANNUAL RESIDENTIAL BRUSH ALLOWANCE

The Culpeper County Board of Supervisors would like to update residents on a new BRUSH POLICY. The new brush policy allows residents to dispose of 1,000 pounds of brush FREE per year. We will track the amount disposed of by each resident using your vehicle license plate number. A **\$67.50** per ton charge will be applied to any load disposed of, regardless of weight, after the 1,000 pound allowance has been met.

Our previous brush policy granted residents three FREE loads of brush per year, regardless of weight. This policy penalized residents who owned smaller trucks as well as cars, since they can only carry small loads. The new policy grants all residents the same 1,000 pound exemption regardless of how the brush is delivered to the Transfer Station. The new policy went into effect on February 1, 2002. Exemptions will be renewed on July 1st of each year.

CULPEPER COUNTY TRANSFER STATION FEE SCHEDULE & HOURS OF OPERATION

FEES:

WHEN SCALES ARE IN OPERATION

- **Municipal Solid Waste (General Waste)**
 - Commercial = \$ 67.50 per ton
 - Residential < 500 lbs = FREE (Limited to one visit per day)
 - Residential > 500 lbs = \$ 67.50 per ton for ENTIRE LOAD
- **Construction Demolition Debris** \$ 67.50 per ton
- **Brush (Wood chips will be considered General Waste)** \$ 67.50 per ton
- **White Goods (A/C, Refrigerators, Freezers)** \$ 10.00 each
- **Whole Tires**
 - Car (Tire Diameter <26 inches) \$4.00 each
 - Truck (Tire Diameter <36 inches) \$6.00 each
 - Oversize Tire (Tire Diameter <46 inches) \$12.00 each
 - Tires >46 inches in diameter Not Accepted
 - Tires on Rims <18 inches in diameter \$12.00 each
 - Rims >18 inches in diameter Not Accepted
- **Non-Friable Asbestos** \$120.00 per ton

WHEN SCALES ARE NOT IN OPERATION

- **Pickup Trucks** \$ 28.00/Load
- **Flatbed/Slat/Dump Trucks**
 - Single Axle \$70.00/Load
 - Double Axle \$155.00/Load

Refuse Trucks and Roll-Offs:

- Un-compacted \$15.00. per cubic yard
- Compacted \$30.00 per cubic yard
