General Information for using the Amissville Refuse & Recycling Center

Rappahannock County operates the Amissville Refuse & Recycling Center. Culpeper County residents have historically been able to drop off residential trash at the Amissville Refuse & Recycling Center, however, as of January 1, 2024, Rappahannock will allow only Rappahannock residents to use the facility due to increases in operating costs.

Rappahannock County has agreed to let Culpeper County residents use the Amissville Refuse & Recycling Center for their residential disposal needs for a fee if Culpeper County Administers the permitting process and reimburses Rappahannock County for their operating expenses.

How much does a decal cost to use the Amissville Refuse & Recycling Center?

Culpeper County will sell an annual decal, pro-rated as needed, to Culpeper County residents that would like to use the Amissville Refuse & Recycling Center. <u>Decals will cost \$168 per year per decal</u>, and the County will match that amount bringing the total to be transmitted to Rappahannock County to \$336.00 per year, or \$28.00 per month per decal. Rappahannock County may revise fees annually. Decals will be valid for one year starting July 1 to coincide with Rappahannock County's fiscal year. Initial decals during the six-month trial period will be prorated until July 1, 2024. New decals will be issued annually.

Where can I purchase a decal to use the Amissville Refuse & Recycling Center?

Residents may purchase Amissville Refuse & Recycling Center decals from:



Residents need to complete the attached application for each vehicle and bring the completed form to the office or email a copy to phoward@culpepercounty.gov. Please call the office at 540-727-3409 to determine the fee. Checks shall be payable to "Culpeper County Treasurer". Credit/Debit Cards are not accepted.

Where do I place the decal?

The Decals must be permanently affixed to the right side of the official state inspection sticker when viewed though the inside of the windshield. The side edge next to the site permit shall not be more than ¼ inch from the edge of the official inspection sticker (per the code of Virginia: 19VAC30-40-30 Placement). The decal is a fast, easy way for the staff to recognize the vehicle as an authorized customer. Vehicles without a properly affixed valid decal will not be allowed to enter the facility.

Culpeper residents must comply with all Rules and Regulations established by Rappahannock County to use the facility.
