DISPOSAL FEES:

RESIDENTIAL First 500 lbs.: No charge ALL OTHERS/Excess: \$50.00 per ton Logs must be smaller than 12-inches in diameter

Construction & Demolition Debris:

Residential Self Home Improvement, Pickup Truck Load or less per week: First 500 lbs. No Charge Excess \$50.00 per ton No Business C&D Debris

METAL: No charge, restrictions apply

IMPORTANT NOTICES:

Metal Bin items may not include: fencing, pressurized gas cylinders of any type (propane tanks, oxygen tanks, fire extinguishers, freon tanks, helium tanks, acetylene tanks, etc. regardless of whether they are empty or not)

ATTENTION CULPEPER RESIDENTS:

You must obtain an annual vehicle decal from the Culpeper Department of Environmental Services before using a Rappahannock County refuse and recycling center.
