#### **CHILDREN AND OUR FIELDHOUSE**

- Ages 16+ may be considered the supervising guardian for siblings age 12 and younger when using the Culpeper County Fieldhouse, provided responsible and appropriate behavior is exercised at all at times;
- Ages 13+ may use the Culpeper County Fieldhouse without adult supervision, unless posted otherwise;
- Ages 10-12 may use designate areas of the facility provided their parent/guardian is on the premises (Inside Fieldhouse/Onsite of complex) and they have completed a facility orientation with their parent/guardian;
- NOTE: Ages 13+ may join as individuals, however, youth 13-17 must have a parent or legal guardian sign the membership agreement and waiver.

#### **UNATTENDED CHILDREN POLICY**

To ensure your child's safety and sense of security, please pick up your child at least 15-minutes prior to the building closing or, for program participants at the end of the scheduled program time. Please verify operating hours and the Fieldhouse schedule for age-appropriate activities prior to leaving your child at the facility.

Parents are advised that staff cannot take responsibility for children who are left unattended. Culpeper County Parks & Recreation Staff may contact the Culpeper Sheriff's Office for assistance if children are left at the facility 15-minutes after closing.

#### **GENERAL FIELDHOUSE RULES**

- All patrons must check in at the Reception Desk. Membership card(s) or day pass(es) must be presented and scanned in order to use the Fieldhouse;
- Patrons are required to wear proper attire when visiting the Fieldhouse. Clothing should not depict lewd graphics or obscene language. Undergarments shall not be visible. Boots or muddy shoes are not permitted in the Fieldhouse. Clean court shoes must be worn at all time;

- The Culpeper County Fieldhouse is considered a family-oriented facility. Obscene language, gestures, inappropriate displays of affection, and participants under the influence of alcohol or drugs/controlled substances will not be tolerated;
- Courteous conduct is expected from all those using our facility or on the facility grounds. Loitering and
  disruptive language or behavior (such as horseplay, profanity, and language or behavior that is profane, vulgar,
  sexual, ethnically degrading, disrespectful or threatening) are prohibited.
- Consumption of snacks will be allowed in designated areas only including the front lobby. Cake, ice cream, cupcakes, pizza, party subs, and any other similar foods consumed by a group are only permitted with a classroom rental. Only water, sports drinks, coffee, and tea in an enclosed container are permitted past the Reception Desk;
- Glass containers of any kind are prohibited in the Fieldhouse;
- Only employees and/or contracted vendors of Culpeper County Parks & Recreation are authorized to provide training, instructions, or lessons on premises owned by the County of Culpeper, Virginia.
- Animals, scooters, tricycles, unicycles, bicycles are not allowed in the Fieldhouse. Service animals are permitted.
- Skateboards and rollerblades may not be used in the Fieldhouse, or near the Fieldhouse front entrance and exits.
- Softballs, baseballs, frisbees, and/or any other thrown equipment are not permitted in the Fieldhouse without prior written approval by the Culpeper County Parks & Recreation Director or his/her designee;
- The use of Culpeper County Parks & Recreation facilities is a privilege and participants, spectators, and visitors
  are expected to be good citizens and respect the right of others. Individuals who engage in unacceptable or
  irresponsible behavior may have their access to the facilities revoked or modified indefinitely;
- Only County materials may be posted on County property. Other items may not be displayed or solicited without prior written approval by the County of Culpeper Parks & Recreation Director or his/her designee;
- Culpeper County Parks & Recreation is not responsible for lost, damaged, or stolen items.;

### **LOCKERS**

- A limited number of lockers are available for use at the Fieldhouse. When entering, insert your items into the locker and insert your own personal code. We do not recommend leaving valuables of any kind in the lockers (e.g., money, wallet, jewelry, electronic devices, etc.)

#### **GYMNASIUM**

- Participants must be 18 or older to participate in adult programs unless an older age is designated with the program description/details;
- Participants must be 50 or older to participate in senior programs;
- Personal training, coaching, and/or team practices are not permitted;
- Gymnasium participants must wear fully-enclosed athletic shoes with non-marking soles.
- Willful misuse, destruction, or vandalism of County property or equipment is prohibited. Hanging on the rims, nets, goals, etc. is not permitted;
- Do not lean, pull, or sit on the divider curtain;
- Bottled water, sports drinks, coffee, and/or tea must be in non-breakable containers. Food and soda are not permitted within the Gymnasium;
- Pants and shorts must be pulled up and undergarments shall not be visible;
- The gymnasium will be scheduled by the Recreation Staff for specific programs (i.e., Adult Basketball, Volleyball, Pickleball, Futsal, Youth Basketball, etc.). During these defined program times, other activities/sports will not be permitted within the gymnasium;
- All materials must be returned to their original storage location upon completion of use. Only Recreation Staff may retrieve equipment from closets.

#### **BASKETBALL HOUSE RULES**

Open Gym basketball for youth and adults provides all basketball players with the opportunity to play regardless of their skill and/or ability. Remember, the spirit of "open play" is that everyone gets to play with different players in a recreational and fun setting.

\*\*\*Culpeper County Parks & Recreation will have a limited amount of equipment onsite available for participant use (i.e., basketballs, volleyballs, paddles, Pickleballs, etc.). However, participants are strongly encouraged to bring their own equipment.

- After registering at the Reception Desk, all players must sign up on an individual players list. No team signups will be permitted;
- The first ten (10) players to signup will play the game;
- At the end of each game, a new team of five (5) players from the list will play the next game. If any of the five
   (5) players do not wish to play, they will be automatically dropped to the bottom of the list;
- If a player comes out in the middle of the game, the next player on the list will join in his/her place. If a player or person waiting leaves the Fieldhouse, he/she will be replaced by the next person on the list. No one may "leapfrog" over any participant(s) that are already registered on the list;
- Full court games are played to 13 by one (1) and two (2) points. A team does not need to win by two (2) points. Maximum time limit for games will be 15-minutes.
- Games played on the side courts will play to 13 by one (1) point. A team does not need to win by two (2) points.
   Maximum time limit for games will be 15-minutes. If the 15-minute period ends in a tie, one (1) 2-minute

overtime will be permitted in order to determine a winner. If the score remains tied at the conclusion of the 2-minute overtime - the next basket wins (Sudden Death).

- At the conclusion of the games, the two (2) winning teams will play on Court B while two (2) new teams will play
  each other on Court A;
- Teams may not play more than three (3) games in a row. In the case where a team wins three (3) consecutive
  games, two (2) new teams will take the court for full court games or four (4) new teams will take the court for
  half court games;
- When both sides of the gym are being utilized, there will be a Court A and a Court B. If you are playing on Court A and your name is called to play on Court B— it will be marked off and placed at the bottom of the list;
- Disputes will be settled by shooting a 3-pointer from the top of the key;
- No backcourt violations;
- Participants will call their own fouls and must honor the call(s) of their opponents;
- Recreation Staff will not keep score;
- For safety purposes, players not playing the game(s) are not permitted to shoot/dribble on the sidelines or hoops while a game is in progress;
- The game clock will not stop for injuries;
- Continued arguing will not be tolerated. A 30-second arguing rule will go into effect as Recreation Staff deem
  necessary. If after 30-seconds, the arguing continues, Recreation Staff have the authority to eject both teams
  from the court and ten (10) new players will be taken off of the list to play in the next game;
- Profanity, abuse of gym equipment/facilities or physical assault(s) will result in expulsion from the Culpeper County Fieldhouse.
- See appendix B for court breakdown of youth open gym age groups.

Open Gym volleyball for youth and adults provides all volleyball players with the opportunity to play regardless of their skill and/or ability. Remember, the spirit of "open play" is that everyone gets to play with different players in a recreational and fun setting.

\*\*\*Culpeper County Parks & Recreation will have a limited amount of equipment onsite available for participant use (i.e., basketballs, volleyballs, paddles, Pickleballs, etc.). However, participants are strongly encouraged to bring their own equipment.

 After registering at the Reception Desk, all players must sign up on an individual players list. No team signups will be permitted;

- When attendance reaches more than 18 players, games will be played to 11 points. The winning team may play only a maximum of two (2) straight games. After winning two (2) consecutive matches, the team must sit out for at least one (1) round;
- When players are available, teams should consist of six (6) players for volleyball.
- Participants will umpire their own game. Please respect and honor the call(s) of your opponent;
- Recreation Staff will not keep score.
- Continued arguing will not be tolerated. A 30-second arguing rule will go into effect as Recreation Staff deem necessary. If after 30-seconds, the arguing continues, Recreation Staff have the authority to eject both teams from the court and ten (10) new players will be taken off of the list to play in the next game;
- Profanity, abuse of gym equipment/facilities or physical assault(s) will result in expulsion from the Culpeper County Fieldhouse.

These rules and regulations serve as guidelines for those using the Culpeper County Fieldhouse. Recreation Staff, when necessary, may modify these rules and regulations to permit all users of the facility the opportunity of participating, and if necessary, determine the order of participation of individuals/teams.

#### **PICKLEBALL HOUSE RULES**

Open Gym Pickleball for youth and adults provides all Pickleball players with the opportunity to play regardless of their skill and/or ability. Remember, the spirit of "open play" is that everyone gets to play with different players in a recreational and fun setting.

\*\*\*Culpeper County Parks & Recreation will have a limited amount of equipment onsite available for participant use (i.e., basketballs, volleyballs, paddles, Pickleballs, etc.). However, participants are strongly encouraged to bring their own equipment.

- Games are 2v2. If there is no one waiting to play no one needs to sit out a game;
- If all courts are full, place your paddle into the paddle stacker to the right of the "next up" marker to enter queue to play. If the queue is between 1-4 players, the rotation becomes 2 ON/2 OFF. If fewer than five (5) paddles are in the paddle stacker, winners stay on for a 2nd game (and preferably split), but do not play more than two consecutive games. If six (6) or more paddles are in the stacker then play moves to a 4 ON/4 OFF rotation.
- Scoring: Games will be played to 11 (win by two). If more than 12 paddles are in the stacker then all games are played to nine (9) points (win by two).
- The rotation will be adjusted to accommodate the number of waiting players so that each individual / team has the opportunity to play.
- Players are responsible for calling the lines on their side of the court. The opponent gets the benefit of the doubt on line calls made. Any ball that cannot be called "out" shall be considered "in." Please respect and honor the call(s) of your opponent.
- Recreation Staff will not keep score. Score must be called for all to hear, by serving team, prior to striking ball for serve.

#### **BADMINTON HOUSE RULES**

Open Gym badminton for youth and adults provides all players with the opportunity to play regardless of their skill and/or ability. Remember, the spirit of "open play" is that everyone gets to play with different players in a recreational and fun setting.

\*\*\*Culpeper County Parks & Recreation will have a limited amount of equipment onsite available for participant use (i.e. rackets, birdies, etc.). However, participants are strongly encouraged to bring their own equipment.

- Games are 2v2. Winners stay on for the next game, but do not play more than twice in a row. If there is no one waiting to play no one needs to sit out a game;
- If you enter the gymnasium and all the courts are full, place your racket down on the front bleacher to "get in line" to play. This is the queue / wait to play;
- Once the queue reaches two (2) players, the rotation is two (2) players off and the next two (2) players in the queue are on.
- The rotation will be adjusted to accommodate the number of waiting players so that each individual / team has the opportunity to play;
- Scoring: Games will be played to 21 (win by two).

#### **FUTSAL HOUSE RULES**

Open Gym Indoor Soccer or Futsal for youth and adults provides all indoor soccer players with the opportunity to play regardless of their skill and/or ability. Remember, the spirit of "open play" is that everyone gets to play with different players in a recreational and fun setting.

\*\*\*Culpeper County Parks & Recreation will have a limited amount of equipment onsite available for participant use (i.e., basketballs, volleyballs, paddles, Pickleballs, etc.). However, participants are strongly encouraged to bring their own equipment.

- After registering at the Reception Desk, all players must sign up on an individual players list. No team signups will be permitted;
- The first twelve (12) players to signup will play the game. \*In special cases, teams can opt to play 3v3, 4v4, or 5v5 depending on the availability of players. In the event that games are started with lesser than twelve (12) players, the expectation is that once new players arrive they will be incorporated into the game;
- \*At the end of each game, a new team of players from the list will play the next game. If any of the players do not wish to play, they are automatically dropped to the bottom of the list;
- If a player comes out in the middle of the game, the next player on the list will join in his/her place. If a player or person waiting leaves the Fieldhouse, he/she will be replaced by the next person on the list. No one may "leapfrog" over any participant(s) that are already registered on the list;
- Full and Half Court games are played to 11. Maximum time limit for games will be 15-minutes.
- For Half Court Games: At the conclusion of the games, the two (2) winning teams will play on Court A while two (2) new teams will play each other on Court B
- Teams may not play more than three (3) games in a row. In the case a team wins three (3) consecutive games, two (2) new teams will take the court for full court games or four (4) new teams will take the court for half court games;
- When both sides of the gym are being utilized, there will be Court A and Court B. If you are playing on Court A and your name is called to play on Court B it will be marked off and placed at the bottom of the list;
- Participants will call their own fouls and must honor the call(s) of their opponents;
- Recreation Staff will not keep score;
- The game clock will not stop for injuries;
- For safety purposes, players not playing the game(s) are not permitted to shoot/dribble on the sidelines or goals while a game is in progress;
- Continued arguing will not be tolerated. A 30-second arguing rule will go into effect as Recreation Staff deem necessary. If after 30-seconds, the arguing continues, Recreation Staff have the authority to eject both teams from the court and ten (10) new players will be taken off of the list to play in the next game;
- Profanity, abuse of gym equipment/facilities or physical assault(s) will result in expulsion from the Culpeper County Fieldhouse.
