This article applies to all signs, of whatever nature and wherever located, within the unincorporated areas of Culpeper County. All signs not specifically permitted or exempted by (11-2-2) this article are prohibited.

#### Sign Permit

The approval of a Sign Permit does not relieve the applicant of the necessity for any other required permits (Building, Architectural Review Board).

## **NOTICE**

Finally, RLUIPA provides that no government may impose or implement a land use regulation in a manner that discriminates against a religious assembly or institution.
